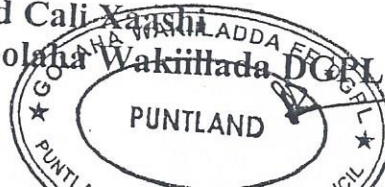

- Iyo xeerarka kale ee heshiisyada mudnaanta gaar ahaaneed, xasaanadaha iyo Tafsiilaadka ku haboon mabaadii'da dukuumentiga shaqada xukumaysa xiriirka ka dhexeeya qaramada midoobey iyo Dowladda Gobaleedka Puntland

Dawladda Gobaleedka Puntland waxay balan qaadaysaa sii-wadidda, dhowrida iyo kaalinta heshiisyada iyo xeerarka kor ku xusan.

Waxaa lagama maarmaan ah in qaramada midoobey & Dowladda Gobaleedka Puntland ay wada jir u samaystaan xeerka wada shaqaynta oo dhammaystiran oo Hay'ada qaramada midoobey kaga howl-galaan Puntland.

Dowladda Gobaleedka Puntland waxay dhowraysaa mas'uuliyada asaasiga ee sharciga caalamiga oo lagu ilaalinayo xuquuqda aadamiga bulshada ku hoos nooi xuduudaha Maamulka Dowladda gaar ahaan hubinta ammaankooda iyo waddada asaasiga ee lagama maarmaanka u ah gaarsiinta waxyaabaha aasaasiga u ah noloshu sida, Cuntada, Hoyga, Biyaha, Caafimaadka iyo Waxbarashada.

Kaalinta Hay'adaha Qaramada Midoobey ee ku sugan Puntland waxay gacan ka siinayaan Maamulka u gargaarida & ilaalinta Xuquuqda aadamiga bulsho waynta si loo fuliyo dhamaystirka mas'uuliyadaha.

Go'aanka Golaha guud ee Qaramada Midoobey ee 9A/47/160 ee September 1993 oo lagu boorinaayo Dawladda iyo Ururada aan dowliga ahayn waxay ka gargaarayaan Soomaaliya dib-u-dhiska asaasiga adeegyada bulshada iyo dhaqaalaha.

Iyadoo la dhowrayo dhaqanka caadooyinka iyo xeerka Puntland iyo hagidda ku dhaqanka mabaadii'da barakaca waxay kor u qaadaysaa xiriirka ka dhexeeya Ururada Caalamka iyo Dawladda Gobaleedka Puntland.

Sidaa awgeed Qaramada Midoobey iyo Dawlad Gobaleedka Puntland waxay wada jir u samaysteen xeer wada shaqayn ku salaysan saaxiibtinimo iyo iskaashi oo ah sida.

1. Kaalinta iyo Masuuliyadaha guud

1.1 Labada garab waxay heshiis ku yihiin ilaalinta , dhawrida iyo qadarinta dhamaan heshiisyada iyo shuruucda caalamiga oo ah:

- Heshiiska jineefa (Geneva Convention) ee 1949 iyo Borotokoolkeeda 1977.
- Heshiisyada caalamiga ee xuquuqda Aadimiga ee 1948
- Heshiisyada caalamiga ee xuquuqda rayidka ,siyaasada ,xuquuqda bulshada iyo dhaqalaha ee 1966.
- Heshiisyada ciribtirka dhamaan qaababka takoorka lid ku ah Haweenka ee 1979.
- Heshiisyada xuquuqda carrurta ee 1989.
- Heshiisyada laxiriira xaalada Qaxootiga ee 1951 iyo borotokolkeeda ee 1967.
- Heshiisyada ururka OAU ee 1969 oo si gaar ah u tilmaamaya dhibaatooyinka Qaxootiga Afrika .

1.2 Xeerka heshiiska wada shaqaynta ee Dawlad Goboleedka Puntland iyo Hay'adaha Qaramada Midoobay ma wiiqaayo , waxna uma dhimayo shuruucda Caalamiga.

2. Kaalinta Dawlad Gobaleedka Punt land

2.1 Kaalinta asaasiga ah ee Maamulka Puntland waa gargaaridda iyo ilaalinta bulsho weynta ku nool xuduudaha hoos yimaada Maamulka Dawlad Gobaleedka Puntland iyo hubinta, aqoonsiga xaquuqdooda asaasiga ah iyo xoriyadooda.

2.2 Hay'adaha Qaramada midoobey ee ka howl-galaya Puntland waxay maamulka ku gacan siinayaan u gargaarida & dhowrida Bulshada inta nugul.

2.3 Dawlad Gobaleedka Puntland waxaa mas'uuliyad buuxda ka saaran yahay ammaanka & ilaalinta Hay'adaha Qaramada midoobey Shaqaalahooda & hantidooda waxaana loo qeexayaa sidan.

- Hubinta amaanka,& nabad galyada Hay'adaha qaramada midoobey Shaqaalahooda iyo hantidooda.
- Hubinta xorriyadda & marinka Hay'adaha Qaramada Midoobey ee ka shaqeeya Puntland ee ka howl-galaya bulshada nugul si ay u qiimeeyaan baahidooda iyo kaalmo gaarsiinta.

- Hubinta in kaalmada caalamiga ah la gaarsiiyey dadkii loogu talagalay.
- Gacansiin iyo iskaashi Hay'adaha Qaramada Midoobey xagga ammaanka shaqaalahooda & nabad galyada xarunta Qaramada Midoobey, garoomada, goobaha la booqanayo, & howlaha mashaariicda ka socda Puntland.

3. Kaalinta Hay'adaha Qaramada Midoobey

- 3.1 Kaalinta Hay'adaha qaramada midoobey ee ka howlgala Puntland waxay siinayaan adeeg & ilaalinta Bulshada nugul. Kaalmadaas oo lagu badbaadinayo nolosha dadka laguna yareynayo dhibka gaaraya si ay u abuuranto jawi nabadeed oo degan.
- 3.2 Mabaaddii'da kaalmada aadamiga waxay ku salaysan tahay dhexdhexaad isu dheeli tir, Sinaan, ka qayb qaadasho, Xisaabtan, Nabad, dib u heshiisiin isu duwid & mideynta ujeedooyinka & mas'uuliyada Hay'adaha Qaramada Midoobey.

4. Isu duwida

- 4.1 Wasaaradda Qorshenta iyo Iskaasiga Caalamiga ah waa Xiriiriyaha Hay'adaha Caalamiga & Hay'adaha Puntland. Xafiiska wakiilka iyo isu duwidda kaalmooyinka ee Qaramada Midoobey waa xiriiriyaha Hay'adaha Qaramada Midoobey. Iyo Puntland iyadoo loo marayo Wasaaradda Qorsheynta iyo Iskaashiga Caalamiga.
- 4.2 Hay'adaha Qaramada Midoobey ee ka mid ah heshiiska waxay la howl galayaan Wasaaradda iyo Hay'adaha Dowlada ee ay wada shaqeynta la leeyihiin iyagoo la saxiixaya Heshiisyada koobina la siinayo Wasaaradda Qorsheynta iyo Iskaashiga Caalamiga ah.
- 4.3 A). Hay'adaha Qaramada Midoobey iyagoo wargalinaya waxay la tashi la yeelanayaa Wasaaradda Qorsheynta iyo Iskaashiga Caalamiga, arimaha Qorsheynta, Mudnaanta, hirgalinta & madasha mashaariicda, warbixinta mashaariicda waxa la soo gudbinayaa saddexdii bilood mar.
B). Hay'adaha qaramada midoobey waxay kala tashanayaan Wasaaradda Qorsheynta iyo Iskaashiga Caalamiga kaalinta Qorsheynta, mudnaan-siinta, isu-duwidda, dabagalka iyo qiimaynta.

Sidoo kale waxay kala tashanayaan Wasaaradda iyo hay'adaha Dawladda ee la howlgala arrimaha isuduwida, dabagalka iyo qiimaynta mashaariicda ay fulinayaan.

- 4.6 Dhammaan workshobyada iyo Siminaarrada waxaa lagu qabanayaa Puntland oo aan ka ahayn kuwa gaar ah.
- 4.7 Mashaariicdu markay dhamaadaan waxa lagu wareejinayaa maamulka Dawladda ay khuseeyso haddii mashruuca loo baahdo in la fidiyo waxa wada jir dib u eegaya Wasaaradda Qorsheynta & iskaashiga Caalamiga iyo Hay'adaha Qaramada Midoobey

5. Mudnaanta Gaar ahaaneed iyo Xasaanadda

- 5.2 Haddii ay qalabka ka timaado dib-u-dhac, soo dejinta iyo dhoofinta waxaa ka wada hadlaya Maamul Gobolleedka Puntland iyo Hay'adaha Qaramada Midoobey

6. Shaqo Qoris

- 6.1 Iyadoo la tixraacayo Axdiga Qaramada Midoobey, Hay'adaha Qaramada Midoobey waxay u madax bannaan yihiin shaqo qorista muwaadiniinta Puntland iyo ciddii kale.

7. Darajada Shaqaalaha Qaramada Midoobey.

- 7.1 Dawlad Gobolleedka Puntland waxay qadarin siinaysaa Madaxda sare ee Hay'adaha Qaramada Midoobey sida heshiisyadu tilmaamayaan mudnaanta gaar ahaaneed iyo xasaanadaha la siiyey Madaxda Qaramada midoobey waa mid aan ka hooseyn tan la siiyo diblumaasiyiinta sida uu qeexayo sharciga caalamiga.
- 7.2 Khuburada u socota hawl-gaar ah oo Hay'adaha Qaramada Midoobey u soo idmaan inay hawlo ka soo qabtaan Puntland waxay leeyihiin mudnaan gaar ahaaneed iyo xasaanad.

- 7.3 Shaqaalaha reer Puntland ee u shaqeeya Hay'adaha Qaramada Midoobey iyo Addeegyada loo sameeyo Hay'adaha Qaramada Midoobey waxaa ku waajib ah canshuur bixin sida uu qeexayo dastuurka dalka. Xil ka ururinta canshuurta waa mid ay fulinayso Wasaaradda Maaliyadda. Hay'adaha Qaramada Midoobey waxay Wasaaradda Qorsheynta iyo Iskaashiga Caalamiga u soo gudbineysaa tirada shaqaalaha u shaqeeya oo cashuurtu ku waajibto, Kirada guryaha, Baabuurta iyo Qandaraasyada IWM.
- 7.4 Madaxda iyo Khuburada Hay'adaha Qaramada Midoobey sida heshiisyadu tilmaamayaan cashuur kuma waajibto mushaharkooda iyo gunnadooda waxaa cashuur ku waajibbeysaa adeegyada loo sameynayo.
- 7.5 Sidoo kale Madaxda iyo Khuburada Hay'adaha Qaramada Midoobey ee hawl gaar ah ku imaanaya Puntland waxaa laga dhaafayaa kharashka Visa-ha iyo waxyaalaha yaryar ee ay wataan.
